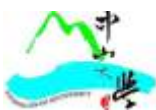

### General Structure

- a) The 2-year fully residential PGDM program comprises of 6 trimesters each of duration varying from 10 to 13 weeks.

### Eligibility

- Graduates/Final Year Graduation students appearing for CAT/XAT/GMAT/ CMAT/ATMA /MAT or who already have valid CAT/XAT/GMAT /CMAT/ATMA/MAT scores.
